

UTAH ACADEMIC DECATHLON STATE COMPETITION CONDUCT FORM

Non-profit organizations, USAD and UAD, require that each decathlete, coach(es) and a school administrator sign a Competition Conduct Form. This form is an agreement between the decathletes, the coach(es), school administrator, USAD and the UAD.

- Each decathlete, coach and administrator is to read and sign the performance agreement statement.
- One form per team, failure to sign and submit the form disqualifies Team and/or Decathlete.
- Non-compliance will result in disciplinary action at the discretion of UAD officials.
- The form will be turned in upon registration for state competition, or prior to any district or regional competition if requested.

I understand that these are official tests of the United States Academic Decathlon and I hereby affirm that I have prepared for and will perform on these tests in a manner consistent with the highest standards of honesty and integrity. Should I choose to use a calculator for the math test, it shall be an acceptable model as stated in the current calculator policy as approved by USAD and the UAD. I will not make any attempt to acquire or to divulge any inappropriate advance information, such as any current test or test items.

I understand and agree that in the case of any questionable conduct, as determined by the UAD officials, I will take a parallel retest, within a given time frame, to provide validation of my scores at the discretion of the UAD officials. I also understand that UAD officials reserve the right, in their discretion, to take any other remedial action that they deem necessary in the event of any misconduct, up to and including individual and or team disqualification, and the UAD officials' determinations of misconduct shall be final. Finally, I affirm that my coach has provided me with all the necessary information concerning the rules and standards of the Competition, the content of the Competition Handbook, and other, relevant Competition materials, including dress and other conduct requirements for competition.
